#### V. EOFPANJ Reports

- a. Vice President Information Only
  - EOFSAA
    - Hema Patel: I think the easiest thing is to create an EOFSAA account and then give them access as well as someone on the E Board. Create a separate account for them and then give them access to that and they can get credit cards or whatever they need. Terrence C Harris: We have to look at the constitution again. The immediate Past President and Janice reviewed that and it was determined that we couldn't do it. We'll need to revisit again. Ruben Melendez: Looking back a few years ago, they utilized our 5013 status and I think that's why it's connected. Terrence, you mentioned they have their own 5013C correct? So, I don't know if that's an issue. They get their own budget. So, you can write them a check for \$2,000 and they can get their own bank account and run affairs with that. There is nothing constitutionally that prevents us from doing that. Arthur Horn: The retired board leadership and the previous board leadership, I offered to come to their meetings anytime that they needed. I sent both groups of leadership access to see the accounts at any time - they just can't do anything with it. Hema Patel: Yes, definitely communication issues. Now we move forward and we develop a plan to get it together. Simone is amazing so if she is willing, she has experience. She's in charge of the alumni association for African-American alumni at Rutgers. Terrence C Harris: Right now during the transition, they have an automatic response that sends emails to me.

  - EOF Men of Color Leadership Summit
    - New Opportunities for EOF Scholars
    - Two weeks ago, we had the Leadership Summit at Kean University. We had over 200 people register and about 150 attend. We look to expand and grow next year. What I wanted to highlight is that we had a career fair and the companies were impressed by our scholars. Pfizer and Pepsi in particular emailed me for future opportunities.
  - EOF Day Capitol Gov Relations Committee
    - We had a great turnout. We had legislatures come talk to EOF. We had student testimonials. One thing I wanted to mention was that a lot of legislatures did not know what EOF was. I mentioned this to the Governmental Relations committee.
      - Questions/Comments: Ruben Melendez Now that the Day at the Capitol is done, do we have a plan moving forward in terms of the advocacy campaign? Do we rally the troops to get more funding? Is there a plan? Chrysten Colacicco: Yes, there is a plan. We had a letter drafted as well as a toolkit. We are also working with two non-profits. We have things in place but we have not met yet since so it's not moving forward. I think we are going to wait until May. John Marshall: We haven't done anything since. But the toolkit is going to be finalized. Right now the points we intend to work on are getting increases for Article III and Article IV finding. We have specific amounts that we are going to ask. We're hoping to have everyone ask the same thing - whether you are an alumni, student or professional. Liz O'Brien: I think we should think about hiring the guy who did the video for the Men of Color Initiative at Kean to go to the Day at Capitol and take video. Maybe he can also go to the Fall Conference and take video as well. We can use these for advocacy opportunities. Maybe if we had a short advocacy video, we could post on social media and tag legislators, if they are not checking emails. Same for our students. Dr. Brett Pulliam: There should be some archival information regarding Day at the Capitol to

assist in the planning process. Losing Sen. Rice was difficult because he helped galvanize other legislators to participate. We should look to find another "in" for next year. This is something that we can't plan a couple of months in advance. This is something that we need to start planning now. Another thing you need to start thinking about is that Sen. Ruiz has really been pushing to change EOF policy, right? I think it's important. I believe she was an EOF student or she's EOF adjacent. She is someone that, as a board, would really need to get an ear; to help her to understand what we're looking at now on the campus level. So build a connection now and start reaching out to those legislators and grabbing one on one conversations from members of the executive board, that will help us as we plan for future events. We are moving into an election year for New Jersey and we don't know what might happen with the new Governor. I can definitely work with the Governmental Relations committee on these efforts. Hema Patel: I would also like to add that there is a position at OSHE called Legislative Liaison. Someone mentioned that maybe the Board can reach out to him - his name is Seth Levin. He's going to be at the graduation ceremony, but shoot him an email. There's definitely restrictions on what OSHE can do but perhaps he can provide guidance on who to reach out to and how to start those relationships as well. Dr. Alex Delgado: To talk a little bit about what Brett mentioned regarding the drive. I know that the President would always send a letter if they weren't able to make it to the budget hearing meetings that kind of spoke on behalf of the association and advocacy. I don't know if that is currently still being done or if it's something more of just we need access to the template that was used in the past that was being submitted for the record. It was always public record even if you google it, you will find previous ones that have been done by Barbara and Penny I think as well. Something again also to add, I would say that should be part of the advocacy are those letters that are being submitted. I know we used to always do not just Day at the Capitol, but we also do budget hearing events. Once we found out where they were, we would organize people to be there. There was one year when it was at Trenton and we gave everyone EOF sashes. We were there and were visible to the community and all the people there. Not sure what efforts are being done on the budget hearing part in regards to advocacy, because that's also where the legislators get to hear the voices of students on the record of why EOF should be reinstated or increased or whatever the association is trying to push forward.

#### b. Immediate Past President

• I am reporting on the Director Summit. The committee met twice. We met this week. The theme of this year is Relax, Relate, Release. We are looking to have it in the DoubleTree by Hilton in Princeton, same location as it was last year. It's going to be three days - June 10-12. This is the week after CTI. The committee met earlier this week and talked about what the budget looks like. It looks like we will be within the budget that was slated from OSHE. It is limited to 30 or 40 individuals. Hema Patel: Just a reminder that we will need the Director's Summit as soon as possible because it takes a while to process and we want to make sure that you get the money so that you can spend it. It can take up to one month. I just sent the CTI budget over.

#### c. Parliamentarian

- A reminder that we did approve the constitutional amendment for us to be able to conduct business at the retreat. That makes us dues paying members. We have to put it out to the body. My thought process is maybe doing that around CTI. Maybe also offer a virtual town hall in case anyone has questions. I will come up with some dates and get that out next month.
- The other thing and this is not part of the parliamentarian role, but I did talk to vendors about giving them the opportunity to speak to the whole body. I had this idea of a sponsored spotlight, creating a zoom session to bring up to the body so that they can give their presentation on their product and their services. With the summer coming up, people start planning their summer so this would be a great opportunity.

- We have another student advisory committee meeting. Those are going well. Our next meeting is going to be on April 23rd.
- We also connected with Dr. Sabb-Dumas for the EOF Ambassador Program. So the idea is to have student ambassadors sell the program. At our next meeting, Dr. Sabb-Dumas is going to do training and then we're going to start off the program officially in the Fall. The training is pretty extensive.
- We are also going to send out a needs assessment for student involvement. How can we best support our programs? Where are they at with student involvement?

# j. CTI Committee

- Currently, we have 44 registrants.

- We currently have two workshop proposals. We are putting on an ask for you all just to encourage those from your campuses to submit proposals if they are interested in doing a workshop.
  - Terrence C Harris: You will get one more proposal from the Board.
- The theme for this year is Trust the Process: Bloom Where You Are Planted. So focusing on our career trajectories and learning and growth. We have 5 different focus areas that we are planning:
  - Career and Vocational Purpose
  - Workplace Resilience
  - Developing Supportive Relationships
  - Growth Mindset versus Deficit Mindset
  - Wellness and Self-Care
- The goal this year is for our new professionals to really think about having new and exciting ways to really challenge themselves, sit in what their career purpose is, grow in the places that they're in and find the best skills and practices to really grow as professionals and as a person in their current work spaces.
- Will be held at Rider University June 4-6. Same location as last year.
